<u>SCAC:</u> ENTER YOUR STANDARD ALPHA CARRIER CODE - THE FIRST FOUR LETTERS ON YOUR PAPS BARCODE STICKERS.

SUBMITTED BY: NAME AND PHONE NUMBER OF A CONTACT PERSON IF WE NEED MORE INFORMATION.

CROSSING DATE: DATE AND TIME WHEN THE DRIVER WILL BE ARRIVING AT THE BORDER CROSSING.

CROSSING AT: NAME OF THE PORT WHERE THE DRIVER WILL CROSS INTO THE UNITED STATES.

SEND COVER SHEET TO: PROVIDE A FAX NUMBER OR EMAIL ADDRESS WHERE TO SEND THE COVER SHEET. ONCE THE EMANIFEST IS ACCEPTED BY U.S.CUSTOMS AND BORDER PROTECTION (CBP) EMANIFEST SERVICE CENTRE WILL PROVIDE THIS DOCUMENT. DRIVERS ARE REQUIRED TO HAVE AN ACE ELECTRONIC MANIFEST COVER SHEET WITH THEM WHEN THEY ARRIVE AT THE BORDER.

<u>DRIVER, CREW:</u> ENTER THE PROPER NAME FOR ALL PERSONS ON THE TRUCK. IF THIS IS THE FIRST TIME THEY ARE CROSSING WITH ACE THEN USE PAGE 2 OF THIS FORM TO SEND ALL INFO REQUIRED. <u>TRUCK,TRAILER:</u> ENTER THE TRUCK AND TRAILER PLATE NUMBERS. DO NOT USE UNIT NUMBERS. IF THIS IS THE FIRST TIME THEY ARE CROSSING WITH ACE THEN USE PAGE 2 OF THIS FORM TO SEND ALL INFO REQUIRED.

TOTAL NUMBER OF SHIPMENTS WITH THIS TRIP: ENTER THE NUMBER OF SHIPMENTS (NUMBER OF PAPS STICKERS) WITH THIS TRIP. MAKE A COPY OF PAGE 1 OF THE ACE EMANIFEST REQUEST FORM AND COMPLETE SECTIONS 2,3,4 AND 5 FOR EACH SHIPMENT/PAPS STICKER.

STATE/PROVINCE: ENTER THE STATE OR PROVINCE OF ISSUE FOR THE LICENSE PLATE DISPLAYED ON THE CONVEYANCE (TRUCK, AUTOMOBILE, BUS, VAN ETC.).

TRUCK VIN NUMBER: ENTER THE SEVENTEEN CHARACTER VEHICLE IDENTIFICATION NUMBER FOR THE CONVEYANCE (TRUCK, AUTOMOBILE, BUS, VAN ETC.).

US ADDRESS ONLY: CBP REQUIRES AN AMERICAN ADDRESS FOR THE DRIVER. IF THE DRIVER DOES NOT HAVE AN AMERICAN ADDRESS LEAVE THIS BLANK. THE CONSIGNEE ADDRESS WILL BE ENTERED.

DRIVER LICENSE NUMBER: ENTER THE DRIVER LICENSE NUMBER.

STATE/PROVINCE: ENTER THE STATE OR PROVINCE OF ISSUE FOR THE DRIVER LICENSE.

CHECK HERE IF THIS IS AN ENHANCED DRIVER LICENSE: CHECK THIS BOX IF DRIVER LICENSE IS ENHANCED. AN ENHANCED LICENSE HAS EXTRA SECURITY FEATURES. CBP WILL ACCEPT THIS AS A SECOND FORM OF IDENTIFICATION. IF THE DRIVER HAS AN ENHANCED LICENSE A PASSPORT IS NOT NEEDED.
